## Fuel and oil policy

The *<u>Fuel and oil policy</u>* has been published on the <u>Administration policies</u> page of the Intranet.

This policy ensures that FRNSW complies with the NSW Government fuel and oil supply contract for fuel and uses fuel and oil efficiently and safely. Staff should note that:

- Odometer readings must be provided to the service station attendant when purchasing fuel.
- Fuel cards must be kept secure, and lost or stolen cards reported immediately.
- You no longer need to keep receipts for fuel purchases.
- All purchases are monitored. Exception reports are reviewed by Commanders and Managers.
- Fuel cards have pre-defined limitations which minimise the opportunity for misuse.
