Recruit Retained Firefighter Program

A revised policy on the <u>Recruit Retained Firefighter Program</u> has been published on the Administration Policies page of the Intranet.

The Recruit Retained Firefighter Program has been reviewed and Compartment Fire Behaviour Training Level 1 has now been incorporated into Phase 1 of the Program.

Recruit Retained Firefighters may now respond to incidents on completion of Phase 1 of the Recruit Retained Firefighter Program. The Officer in Charge of the crew must ensure that the Recruit Retained Firefighter is tasked with activities and provided with supervision appropriate to their level of training and experience.

Where a crew comprises four firefighters, only one Phase 1 trained Retained Firefighter can be included as part of that crew.

For ease of identification and safety, Phase 1 trained Retained Firefighters must wear Recruit epaulettes until completion of Phase 2 training.

This policy rescinds In Orders 2005/25, *Recruit Retained Firefighter Program*, and Safety Bulletin 2010/03, *Retained Firefighter response*.

The check sheets will be printed and distributed in hard copy shortly, for filing in the A5 SOG check sheet folder carried on appliances. In the meantime, you can print out temporary A5 check sheets and file them in the A5 folder. There are instructions on <u>printing temporary SOG check sheets</u> on the Lessons Learned Centre site. Also print and file the updated <u>check sheet folder contents</u> from the Lessons Learned Centre site.

GENERAL

Churchill Fellowships

The Winston Churchill Memorial Trust was established in 1965 to recognise and perpetuate the memory of Sir Winston Churchill by the award of Churchill Fellowships.

Fellowships provide the opportunity, by way of financial support, to enable Australians from all walks of life to undertake overseas study, or an investigative project, of a kind that is not fully available in Australia. Churchill Fellowships cover overseas travel for about 4-6 weeks. Fares, fees and a living allowance are paid. The average value of a Churchill Fellowship is over \$20,000. In addition, if the research project is fire and rescue industry related, FRNSW may also grant leave on full pay during the period of overseas travel subject to Department of Premier and Cabinet guidelines.

There are no prescribed qualifications, academic or otherwise. Selection is based on merit of the research project, combined with the applicant's past achievements or a demonstrated ability for future achievement. To be successful, a proposed research project must be able to demonstrate a benefit to the wider Australian community, not just an internal benefit to the fire and rescue service.

Upon completion of travel a Fellow is required to submit an extensive report of findings to the Winston Churchill Memorial Trust. If you have been granted leave on full pay for an industry related research project then a copy of the report must also be submitted to FRNSW.

Applications opened on Thursday 1 November 2012 for Year 2013 Fellowships, with travel commencing from 1 September 2013, and are welcome from all areas of the department, including firefighters, administrative and trades staff.
