PROCEDURES

Recommended practice – Emergency medical treatment pack

Recommended practice, <u>Emergency Medical Treatment pack</u> (Ver 04) has been published in the <u>Recommended practices</u> toolkit on the FRNSW intranet.

This recommended practice guides operators in the correct use of the trauma and resuscitation first aid equipment stowed in the EMT Pack. The recommended practice has been revised to include new infection control procedures, update stowage and include new inventory items.

Station Commanders must ensure firefighters using this equipment are aware of the new recommended practice and that EMT Packs comply with the new inventory and stowage, including:

- Removing any alcohol-based antiseptic hand rub from the EMT Pack and ensuring the pack is stocked with 20 Cetrimide antiseptic swabs.
- Ensuring older style blue bag valve masks still in service are disposed of and replaced.
- Ensuring bag valve masks are single use only, and are disposed of after use.
- Removing viral filters from the pack.
- Adding the following items to EMT Packs: disposable nitrile gloves (box 100), safety glasses, P2 masks, Bodok seals, and infectious waste bags. While P2 masks can be obtained from station supplies, the remaining items should be ordered on ESCAT.

Cervical collars have been supplied for all EMT Packs. When required, reorder from ESCAT.

Recommended practice – Portable Kitchen fire simulator

Recommended practice, Portable <u>Kitchen Fire Simulator</u> has been published in the <u>Recommended practices</u> toolkit on the FRNSW intranet.

This recommended practice guides operators in the safe operation of the Kitchen Fíre Simulator, used by trained FRNSW operators to demonstrate the dangers of kitchen fat fires to the public. The recommended practice has been revised to include an increased safety distance for members of the public, include cleaning materials and requires both operators to be trained on the equipment.

Station Commanders and fire fighters using this equipment should review the Portable Kitchen Fire Simulator recommended practice prior to using this equipment.
